### Certificate Training

(24.0 PDHs, 2.4 CEU, 24.0 AIA LU)

The IAM Certificate recognizes individual asset management knowledge and understanding of the fundamental principles of asset management.

To be awarded the IAM Certificate, candidates will need to pass a two-hour online exam. The training modules that form the basis for the exam are as follows:

- Principles of Asset Management
- Asset Management Policy, Strategy & Planning
- Managing Asset Life Cycle Decisions & Activities
- Assessing & Managing Asset Management Risks
- Finance and Business Impact

*We offer Certificate Training in both virtual and on-site settings with three-day or multiple-day schedules. The online exam is administered by Pearson VUE testing centers with a separate fee paid directly to the IAM.*
